As a starting point, search for sources that explicitly analyze gender issues by using gender-related search terms. A review of sector-specific gender analyses relevant to the project, even dealing with a different country, can be helpful for identifying common gender gaps and root causes of gender inequality related to the project's sector(s). In addition, review sector-specific publications that — though they may not explicitly address gender — can lead to areas for further inquiry. <u>Annex 5: Gender Analysis Domains and</u> <u>Customized Questions</u> includes a list of resources relevant to more than 14 sectors.
